## BASIC SAFETY RULES FOR TEMPORARY CONTRACTORS,

1.1	<b>Use of Personal Protective Equipment (PPE):</b> All workers are required to be worn minimum PPE's, such as safety Helmet (Hard Hat), Hi – Viz Jacket and Safety shoes
1.2	<b>Third party certification for lifting Machineries / Equipments / Lifting gears:</b> Should have a valid third party certificate
1.3	Crane Operators / Rigeers: Should have a competency certificate
1.4	Use of generators and temporally electrical conections: All generators should be sound proof, use of domestic socket or unsafe connecting through open wires are strictly prohibited. After the usage, all temporally power conections should be removed.
1.5	<b>Vehicle Accident:</b> Do not drive the vehicle more than 30Km/h at any location inside the project, never walk in the middle of the access road. If any accidents happen, need to inform security officer in the area and safety Engineer – TP 0701372915

1.6	Other accidents / injuries:

1.7	Fire hazard
	If any hot work / use of generators / use of compresures, it is compulsory to provide
	required number of fire extingushers before commence the work.
